Early Head Start 2014 Annual Report

Community Action of East Central Indiana, Inc. (CAECI) Early Head Start is a federal program that provides comprehensive child and family development services for low-income pregnant women and families with infants and toddlers, including those with disabilities, ages six weeks to three years. The purpose of the program is to enhance children's physical, social-emotional, language, and intellectual development; support parent's efforts to fulfill their parental roles and become engaged in their child's education as their child's "best" first teacher; and help parents move toward self-sufficiency. CAECI Early Head Start offers center-based (four classrooms in one child care center) and home-based program options that serve 64 infants and toddlers and pregnant women in Wayne County.

(CAECI) Early Head Start is dedicated to improving the community by enhancing the quality of life for children and their families through a range of developmental services including: learning experiences and nutrition, as well as physical and mental health. 




